3 POLICY AND DECISION MAKING

3.1 MĀORI REPRESENTATION AND THE ESTABLISHMENT OF MĀORI WARDS

The Strategic Advisor Māori summarised the report.

Cr Yvonne Westerman entered the meeting at this point (9.33am).

The Strategic Advisor Māori outlined options available to the Council and added that she had spoken with Mr George Asher, Te Kotahitanga ō Ngāti Tūwharetoa (TKNT), who had confirmed that one hapū, Ngāti Tūrangitukua, supported the establishment of Māori wards and TKNT supported the hapū's view, noting that wards were one part of a package of actions to enhance Māori representation for the Taupō district. An email from TKNT was received and circulated during the meeting (A2817996).

Members made speeches expressing their views on Māori representation and whether or not Māori wards should be established.

The Strategic Advisor Māori advised that she had spoken to officers at the Department of Internal Affairs who were cognisant of the need to include transitional provisions for any councils who had had decisions overturned by a poll, so they would not be bound for six years, in the event that the legislation was changed to remove the poll provisions.

Continuation of the Māori representation project was supported and it was decided that Māori wards would be established for the 2022 elections.
