Plan Change 36 was notified on October 31, 2019. The Plan Change Request seeks to rezone land to the north of the existing Whareroa settlement from Rural Environment to Residential Environment and subject to a 'Whareroa North Outline Development Plan' to guide supporting infrastructure provision and enable up to 160 residential dwellings.

• Any person that has an interest in the proposed plan change greater than the interest that the general public has; and The local authority itself.

Further submissions must be in accordance with Form 6 of the Resource Management (Forms, Fees, and Procedure) Regulations 2003 and must state whether you wish to be heard in support of your submission.
