**The Application:**

This is an application by **Tamzen Louise Winder** for a Managers Certificate pursuant to Section 219 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 22nd July 2020.

1. The applicant holds the Licence Controller Qualification and assists at the Taupo DC Social Club events that are covered by a Special Licence. She agrees to have the certificate tagged to Taupo DC Social Club events.
2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
3. Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the granting of the application. Accordingly, the application is dealt with on the papers.
4. The application and supporting information satisfies the Committee that the criteria we must have regard to, as set out in Section 222 of the Act have been met.

### Manager's Certificate

Section 217 - Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012

**Tamzen Louise Winder**

Certificate Number: **20/CERT/2631/2020**

is authorised to manage any licensed premises in respect of which a licence is in force.

Subject to the requirements of the Act relating to fees and to the provisions of the Act relating to the suspension and cancellation of manager's certificates, this certificate shall continue in force:

- a) Either:
1. Until the close of the period for which it was last renewed; or
  2. If it has never been renewed, until the close of the period of twelve months after the day it was issued; but
- b) If an application for the renewal of the certificate is duly made before the certificate would otherwise expire, either:
1. Until the close of the period of three years after the period for which it was last renewed; or
  2. If it has never been renewed, until the close of the period of four years after the day it was issued.

This certificate expires on **4 August 2021** if not renewed.
