IN THE MATTER of an application by Taupo Cosmopolitan Club Incorporated, for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **5 Taniwha Street, Taupo**, and known as **Taupo Cosmopolitan Club**

The Application:

This is an application by **Taupo Cosmopolitan Club Incorporated** for the renewal of a **Club Licence** in respect of the Licensed Premises known as **Taupo Cosmopolitan Club**, situated at **5 Taniwha Street, Taupo**. It was formally received by the Taupō District Licensing Committee on 16th May 2021.

The applicant is the holder of a **Club Licence** [Licence Number **20/CL/0020/2018**] which was last renewed by the Taupō District Licensing Committee on 18th June 2018.

The application was duly advertised on the Taupō District Council website from 18th May 2021 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

Reasons for the Decision:

The applicant is a responsible entity to hold a Club Licence and certificated managers are employed to manage the sale, supply and consumption of alcohol.

Neither the Police nor the office of the Medical Officer of Health has raised any matters in opposition.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupō District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued.

Notice of Renewal of Club Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **Taupo Cosmopolitan Club Incorporated**

Licence **20/CL/0020/2021** replaces licence **20/CL/0020/2018**

The Club Licence in respect of the premises situated at **5 Taniwha Street, Taupo** known as “**Taupo Cosmopolitan Club**” is renewed.

The present conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed for three years and expires on 12 July 2024.
