The Application:

This is an application by Krishneel Naidu for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 11th November 2021.

1. The applicant holds the Licence Controller Qualification and the LCQ Bridging Certificate and is employed in licensed premises.
