

IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by Ruapehu Food Warehouse Limited for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **131 Ruapehu Street, Taupo** and known as “**Taupo Pak n Save**”.

THE APPLICATION

This is an application by **Ruapehu Food Warehouse Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Taupo Pak n Save**, situated at **131 Ruapehu Street, Taupo**.

The applicant is the holder of a **Off Licence** [Licence Number 20/OFF/0098/2019] which was first granted by the Taupō District Licensing Committee on 15th July 2019.

The application was duly advertised on the Taupo District Council website from 26 May 2020 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

REASONS FOR THE DECISION

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

THE DECISION

We are satisfied as to the matters to which we must have regard as set out in the Act and we approve the renewal of an Off Licence authorising the sale and supply of alcohol for consumption off the premises.

I direct that a notice of renewal and a replacement licence be issued.

The Off Licence in respect of the premises situated at 131 Ruapehu Street, Taupo known as “**Taupo Pak n Save**” is renewed.

The present conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.
