The Application:

This is an application by Mustard Seed Cafe Limited for the renewal of an **On Licence** in respect of the licensed premises known as **Mustard Seed Cafe**, situated at **260 Te Rangitautahanga Road, Turangi**. It was formally received by the Taupō District Licensing Committee on 12th December 2018.

The applicant is the holder of an **On Licence** 020/ON/0047/2016 that was last renewed by the Taupo District Licensing Committee on 29 February 2016.

The application was duly advertised on the Taupo District Council website from 14 December 2018 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.


The Reasons for the Decision:

Notice of Renewal of On Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **Mustard Seed Cafe Limited**

Licence **20/ON/0047/2018** replacing licence **20/ON/0047/2016**

The On Licence in respect of the premises situated at 260 Te Rangitautahanga Road, Turangi known as **“Mustard Seed Cafe”** is renewed.

The current refreshed conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—
