

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012 (the Act)

**AND**

**IN THE MATTER** of an application by Taupo NZ Limited for the variation and renewal of an ON licence pursuant to Section 120 and 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 15 Tongariro Street, Taupo and known as “**Mulligans Public House**”

**The Application:**

This is an application by Taupo NZ Limited for the variation and renewal of an **On Licence** in respect of the licensed premises known as **Mulligans Public House**, situated at **15 Tongariro Street, Taupo**. It was formally received by the Taupō District Licensing Committee on 3rd July 2022.

The applicant is the holder of a **On Licence** [Licence Number **20/ON/0191/2019**] which was last renewed by the Taupō District Licensing Committee on 19 July 2019.

The application was duly advertised on the Taupo District Council website from 7 July 2022 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years and the request to modify the conditions relating to the appointing of COA qualified door staff and for an earlier start time to offer breakfasts. .

**The Reasons for the Decision:**

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

**The requests for variation are granted however we remind the applicant that the gaming machines can not be operated unless the premises is operating as a tavern i.e. the principal activity occurring must be the sale, supply and consumption of alcohol.**

**No venue can be operating principally as a gaming venue. This will be strictly monitored and enforced by the agencies.**

**The Decision:**

Subject to the above, we are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on amended conditions

### **Notice of Renewal and Variation of On Licence**

*Section 135, Sale and Supply of Alcohol Act 2012*

To: **Taupo NZ Limited**

Licence **20/ON/0191/2023** replacing licence **20/ON/0191/2019**

The On Licence in respect of the premises situated at 15 Tongariro Street, Taupo known as “**Mulligans Public House**” is varied and renewed.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

**The licence is renewed for three years and expires on 9 July 2025.**
