

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012 (the Act)

**IN THE MATTER** of an application by Taupo Brewery Limited for the renewal and variation of an ON licence pursuant to Section 120 & 127 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 133 Tongariro Street, Taupo and known as “**Crafty Trout Brewing Company.**”

**The Application:**

This is an application by Taupo Brewery Limited for the renewal and variation of an **On Licence** in respect of the licensed premises known as **Crafty Trout Brewing Company**, situated at **133 Tongariro Street, Taupo**. It was formally received by the Taupō District Licensing Committee on 23rd March 2023.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0189/2020] which was last renewed by the Taupō District Licensing Committee on 8 April 2020.

The application was duly advertised on the Taupo District Council website from 11 April 2023 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

**The Reasons for the Decision:**

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

We are satisfied that the business operates as a tavern and not as a Class 1 restaurant as previously approved. The request for variation is approved and an additional condition including a designation of Supervised Area is imposed.

**The Decision:**

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal with variation on amended conditions.

### **Notice of Renewal with Variation of On Licence**

*Section 135, Sale and Supply of Alcohol Act 2012*

**To: Taupo Brewery Limited**

Licence **20/ON/0189/2023** replacing licence **20/ON/0189/2020**

The On Licence in respect of the premises situated at 133 Tongariro Street, Taupo known as “**Crafty Trout Brewing Company**” is renewed.

The amended conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

**The licence is renewed for three years and expires on 8 April 2026.**
