## **DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE**

## The Application

This is an application by **Greenstone Entertainment GP Limited** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **Taupo Summer Concert 2021**. It was formally received by the Taupō District Licensing Committee on 19th November 2020.

#### **Reasons for the Decision**

The applicant is an experienced operator and has promoted and managed similar concerts for several years in Taupo, Gibbston Valley and Whitianga.

This year there has been a number of changes following productive meetings between the applicants and the agencies. Significantly there will be no wine bottles sold in public areas and other host responsible actions have been taken.

The final reports of the Police and the Medical Officer of Health do not oppose this application.

# **The Decision**

I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

- 1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: Saturday 30 January 2021 from 10.30am to 5.30pm (Public Bars); and from 11.00am to 5.30pm (Corporate Bar). The special licence for the entire venue will operate until 7.30pm.
- 2. The two Public Bar sales areas are designated as Restricted areas. The Corporate Hospitality area is designated as a Supervised area. The two public bar areas and the corporate hospitality area is identified on the concert layout plan date stamped as received by Taupo District Licensing Committee on 19 November 2020.
- 3. Intoxicated persons must not be served and are to be removed from the venue and minors must not be served alcohol.

- 4. Drinking water must be freely available at both public bars, and at the corporate area bar. Two large "water tanker trucks" shall be located at either side of the venue, with taps available on each truck for patrons to access free drinking water.
- A certificated manager must be on duty at all times <u>at each bar facility</u>, within the licensed area, when
  the premises are open for the sale and supply of alcohol and their full name must be on a sign
  prominently displayed.
- Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 7. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 8. Only the following types of alcohol are to be sold at the event: Beer, Craft beers, Wine, Sparkling wine, Ciders, a selection of pre-mixed RTD products and Seltzers. No free-pour spirits are to be sold at the event.
- 9. Alcohol is to be sold in the following types of containers: Beers, Cider & pre-mix RTD's & Seltzers will be sold in cans, and Wine will be sold in plastic cups. In the Corporate area wine can be served in 750ml size glass bottles.
- 10. Cans and bottles are to be de-pressurised at point of sale from 10.30am.
- 11. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - A copy of the licence attached to the premises so as to be easily read by persons attending the premises.
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty at each bar facility.
  - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
- 12. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
- 13. The licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:
- a) <u>Alcohol serves: Public bars</u> a Maximum four alcoholic drinks can be sold to one person at any one time from 10.30am to the reduction time of 4.00pm. From 4.00pm this will reduce to two alcoholic drinks until both public bars close at 5.00pm.

- b) <u>Alcohol serves: Corporate Bar</u> a Maximum of four alcoholic drinks <u>or</u> One 750ml bottle of Wine can be sold to one person at any one time from 11.00am to the reduction time of 4.30pm. From 4.30pm this will reduce to two plastic glasses of wine (i.e. wine will be sold by the glass) or two other alcoholic drinks until the bar closes at 5.30pm.
- 14. A One-Way Door (OWD) Policy shall apply and no Pass Outs are to be permitted, except on medical grounds.
- 15. Police have the ability to change alcohol service sizes, or to close all or any bar at any time based around crowd behaviour, or to change the time of depressurisation of cans & bottles to earlier in the day. These decisions will be based on review meetings with Greenstone Entertainment GP Limited, the Taupo Police, the Taupo District Licensing Committee Inspector, the Medical Officer of Health representative and the Concert Promoters.

The licensed premises known as the 2021 Taupo Summer Concert situated at the Taupo Amphitheatre & Riverside Park, 11 Redoubt Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 19 November 2020.

# Taupo District Licensing Committee Special Licence – On Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **Greenstone Entertainment GP Limited** is authorised to sell and supply alcohol, on the premises situated at Taupo Amphitheatre & Riverside Park, Redoubt Street, Taupo, and known as Riverside Park, Taupo for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **Taupo Summer Concert 2021.** 

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

#### Conditions:
