The Application

This is an application by Taupo Racing Club Incorporated for an on site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Horse racing events x4. It was formally received by the Taupō District Licensing Committee on 16th June 2023.

Reasons for the Decision

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.

The Police and Medical Officer of Health reports raise no matters in opposition.

The Decision

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the sale and supply of alcohol to any person attending the following occasion or event (or series of occasions or events): Horse racing events x4.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.

On Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Taupo Racing Club Incorporated** is authorised to sell and supply alcohol, on the premises situated at 471 Centennial Drive, Rotokawa, Taupo, and known as Taupo Racing Club for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events):
Horse racing events x4.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:
Wednesday 23 August 2023 – bars to open 30 minutes before the first race & close 30 minutes after the last race (“Fiber Fresh Stud Day 2023”);
Friday 15 September 2023 – bars to open 30 minutes before the first race and close at 7.00pm (“Get Set Event Hire Ladies Day 2023”);
Wednesday 11 October 2023 – bars to open 30 minutes before the first race & close 30 minutes after the last race (“Placemakers/Generation Homes Tradies Day 2023”); &
Tuesday 7 November 2023 – bars to open 30 minutes before the first race & close 30 minutes after the last race (“Virtual Melbourne Cup Race Day”).
2. Free-poured spirits are permitted to be served in the Members Marquee only. No free-poured spirits are to be served in the public area/s.
3. A maximum limit of four alcoholic drinks will be served to one person at each transaction.
4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
5. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard
7. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages
8. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
 - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

DURATION

This licence is only in force as specified in Condition 1.

THE LICENSED PREMISES

The licensed premises known as “Taupo Racing Club” situated at 471 Centennial Drive, Rotokawa, Taupo, is more precisely identified as outlined in the Event Site Plan provided with the application, as received by the Taupo District Licensing Committee on 16th June 2023.
